**Terms and Conditions:**

1. whilst every effort will be taken to safeguard the health and safety of any minors attending rehearsals or performance of the production of Oliver and who are at that time under the supervision of DMDS and its designated officers, minors are nonetheless entered at their own risk and DMDS can take no responsibility for any accidents or injuries arising to minors whether during rehearsals or performance or otherwise.
2. In entering minors to participate in rehearsals and the performance of Oliver, parents accept responsibility for advising their children of the need to heed the instructions of DMDS designated officers, designed to protect their own safety and wellbeing, and to observe good behaviour, courtesy and respect to each other as well as all cast and production members. Failure to observe good behaviour may result in a child being refused permission to continue with rehearsals and participating in the performance. DMDS designated officers will bring any information regarding unacceptable behaviour to the attention of parents at the earliest notice and will handle any such issues directly with the relevant parents.
3. In the event of any minor Injury occurring to a minor/child during rehearsals or performance, such as cuts, scrapes, bruises etc. parents hereby consent to the DMDS First Aid Officer (Garda vetted) to administering basic first aid at the time of injury if required and the relevant parents will be notified of any such incidents. In the event of serious injury, the relevant parents will be telephoned immediately and must ensure that they are able to accept calls during rehearsal or production times. In that respect, at least 2 telephone contact numbers must be provided to DMDS for each minor. In the event that DMDS cannot reach a parent during an emergency the designated officers will exercise their best judgment to protect the health safety and wellbeing of the child pending contact from the parent.
4. DMDS will have designated Garda vetted child protection officers at all rehearsals, and performances and we will comply with all relevant child protection policies and procedures.
5. Parents are fully responsible for dropping their children at rehearsal times promptly and picking them up promptly. Failure to heed these requirements, which are in the overall best interests of the production and enjoyment of the experience for all involved, may result in the child being refused permission to continue participating in the production.
